
### **Front Springs Prep:**

- Replace stock Bottom Springs with supplied SuperATV Spring p/n CS-12x3x250.
- Replace stock Top Springs with supplied SuperATV Spring p/n CS-5x3x50.




### **Uniball installation:**

- Bolts are factory equipped with a self-locking bond.
- If bolts are removed:
  - remove all bonding material from threads.
  - apply new thread locker.
- Reinstall and torque to 42 ft/lbs.

- If set screws are removed:
  - remove all bonding material from threads.

- Reinstall and torque to 25 in/lbs.






## Front A-Arms Prep:

- Install stock Bushings and Pivot Shafts or optional SuperATV A-Arms Bushings Kit.
- Install Fittings as shown.
- Set Pivot Blocks to dimension shown.




### **PIVOT BLOCK SETTINGS**

- Place new A-Arms onto a flat surface and verify dimension shown.
- Negative 1° camber setting is achieved when Pivot Blocks are set to this dimension.
- See last page for additional camber information.




\*Leave Jam Nuts loose. Tighten after final adjustments have been made.



### Front:

- Install new Axle.
- Secure A-Arms (C)(D) to Frame with stock hardware. **Do not install any Nuts to Lower Arms all final** adjustments have been completed.
- Repeat for opposite side.



If applicable, refer to SB-P-RZR1K installation instructions and install Swaybar at this time.

- Secure Shock to Frame and Driver Upper A-Arm (C) with stock hardware.
- Repeat for opposite side.
- Reinstall stock components to A-Arms with stock hardware.







## **Rear Springs Prep:**

- Replace stock Bottom Springs with supplied SuperATV Spring p/n CS-16x3x350.



### Rear:

- Secure Passenger Trailing Arm (K) to stock mounting location with stock hardware and supplied Trailing Arm Bushings.
- Install new Axle.
- Install Wheel Bearing to Passenger Trailing Arm (K) with stock hardware.
- Secure Shock to stock mounting location and Passenger Trailing Arm (K) with stock hardware.





- Tighten all hardware completely.






### Radius Arms: passenger side shown.

- If machine has SuperATV RB-P-RZR1K Rear Bumper see "Install Option A".
- Machines without a Rear Bumper use "Install Option B".
- Use stock hardware when securing.
- Repeat for opposite side. Tighten stock hardware completely.





# **Radius Arms Adjustment:**

- If Hubs and Axles do not rotate freely, equally adjust Radius Arms "out" in small increments.
- Tighten hardware completely.






- Install provided Brake Lines and secure to Trailing Arms (K)(J).

- Ensure that no binding or rubbing can occur after installation.

Rear Brake Lines have different style fittings at each end.







### **Rear continued:**

- Secure Sway Bar Link (G) to Trailing Arm and Sway Bar with stock hardware and supplied Bushings.
- Repeat steps for opposite side.
- Tighten all hardware completely.



- Reinstall Tires and check Camber settings; see last page.
- Add Nuts to previously installed hardware and tighten completely. SuperATV recommends using Loc-Tite on Nuts.

### **CAMBER**

- Tires must have equal air pressure before making adjustments.
- Adjustments to be made after all suspension components have been completely assembled.
- Tires must not be in contact with ground when making adjustments.
- Perform adjustments in small increments.





# Adjusting Camber:

- Remove A-Arms from Frame and turn Pivot Blocks to adjust camber. Reinstall Arms.
- Lower machine and settle suspension components by rolling machine back and forth several feet at a time.
- Check settings and make small adjustments as needed.
- Each time an adjustment is made, machine must be rolled back and forth to settle suspension components.
- Once desired setting is achieved, tighten hardware completely. Loc-tite on Nuts is recommended.

### A NEGATIVE CAMBER SETTING OF 1° to 2° IS RECOMMENDED.

#### LOWER:

Too much positive camber: adjust Pivot Blocks *OUT*. Too much negative camber: adjust Pivot Blocks *IN*.



note: 2 full turns is 1°




# **Heavy Duty Tie Rod Kit**

### For use on Polaris RZR® XP 1000 with SuperATV p/n LTK-P-RZR1K-3

**Wire Ties** (2 x short and 2 x long)




Read instructions and view illustrations before beginning.



- 1. Remove stock Tie Rods from Spindles and Rack and Pinion.
- 2. Install Ball and Socket to Rack and Pinion. Use Loctite. See Fig. 1.
- 3. Remove, and keep, Jam Nut from Ball and Socket. See Fig. 1.
- 4. Install Boot, or reuse stock, as shown in Fig. 2. Use a lubricant to ease installation.
- 5. Reinstall Jam Nut and install Shaft to Ball and Socket. See Fig. 2.
- 6. Secure Rubber Boot with Wire Ties. See Fig. 2.

# Kit includes hardware for 2014 and 2015+ models. Use stock Spindle hardware to determine which hardware kit to use. See page 3.


- 7. Secure Tie Rod End to Spindle with supplied hardware.
- 8. Repeat steps for opposite side.





- 2. Align to machine and tighten all hardware.




- 1. Insert Sway Bar (A) into Bumper (B).


