


## Rear Cargo Box: for Kawasaki Teryx® KRX™







**WHEN INSTALLING COMPONENTS, DO NOT TIGHTEN ANY HARDWARE COMPLETELY**

- install Mounts to Bed with components and hardware shown




- repeat for left side
