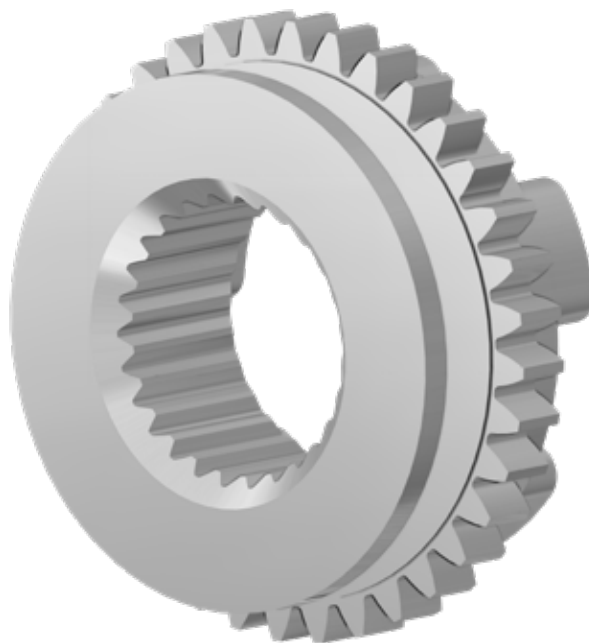


**Differential Locking Ring:

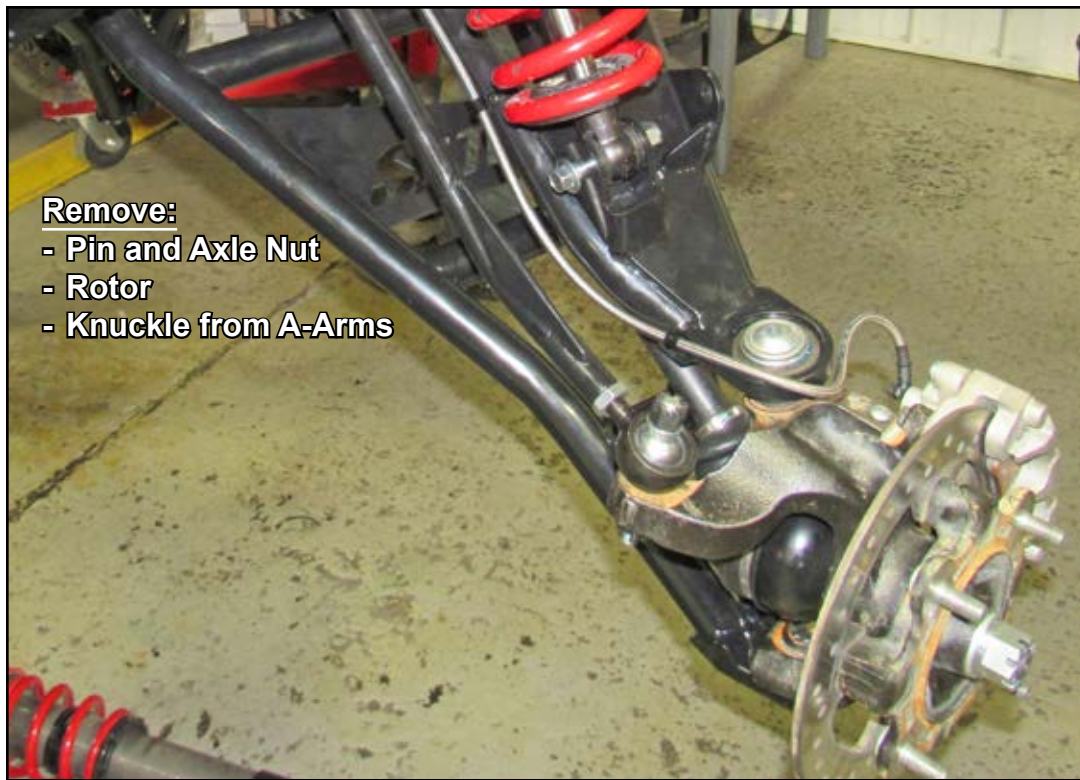
