


## INSTALLATION INSTRUCTIONS

**Two Seater Crossmember: PCM-P-PROXP** 

Please look through and read these instructions BEFORE starting so you understand what processes you'll be doing, and possible extra tools you may need.

Do Not discard product packaging until installation is complete and functioning properly.





**1**.The first thing you need to do is remove any Factory or other Skid Plates from the machine in the center under the Carrier Bearing area as shown in **Fig.1**.



2. Then you need to **Remove** the **Factory Crossmember** by removing the **Two (2) Bolts** on top the carrier bearing flanges that hold it to the crossmember, see **Fig.2a**. **Fig.2b** shows them removed.

**3**.Then **Remove** the **Four (4) Bolts** holding the crossmember to the bottom of the vehicle as shown in **Fig.3a**. Then remove the crossmember from the vehicle ready to install the new crossmember as shown in **Fig.4b**.



**4**. Now **Install** the **New Crossmember** by reusing the Factory Bolts you previously removed when removing the factory crossmember. Install all bolts but do not tighten yet. See **Fig.4a-b**.

**5**.And **Install** the **Two (2) Bolts** on top off the Carrier Bearing that holds it to the Crossmember and See **Fig.5**. Now go back and tighten all bolts secure. Replace Skid plates.


