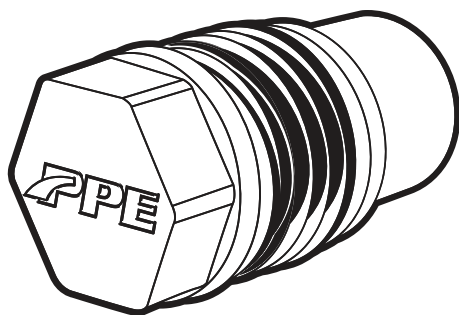

Installation Guide

These instructions are not intended as a service or overhaul manual. These instructions are intended to facilitate the modification of non-factory parts installation by a trained professional.



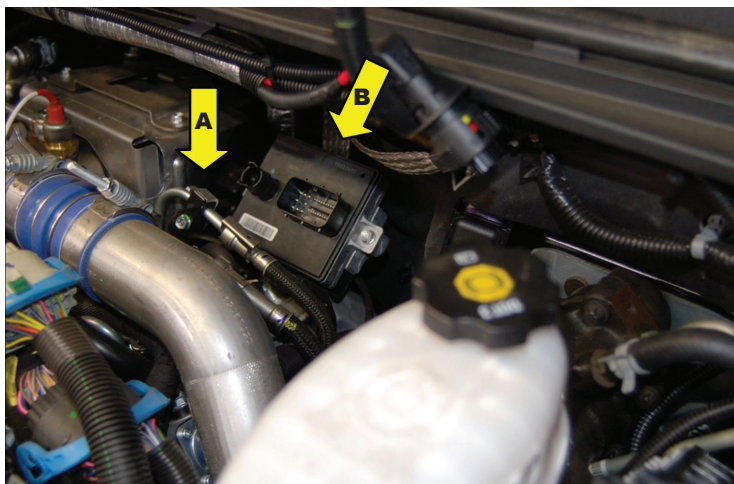
UPGRADE YOUR WORN O-Ring

The companion to the PPE Race Fuel Valve is this Viton O-Ring. It is made from high-quality, chemical-resistant Viton rubber. This O-ring is better than the stock unit and will last longer, too!

Step 1

Remove fuel line bracket (A), disconnect and remove two the (2) bolts securing glow plug controller to controller bracket (B).



Step 2

Remove glow plug control module heat shield's (2)bolts.

Step 3

Remove the (4) bolts securing the glow plug control module.

Step 4

Remove glow plug module.

Step 5

Remove the factory valve from the fuel rail with an 18mm wrench. Replace worn O-ring with a PPE Viton O-Ring (113073001). Lubricate threads and sealing surface with petroleum jelly. Install the PPE Race Fuel Valve. Torque to 72 - 74 ft. lbs.

Step 6

Reinstall brackets, heat shield, glow plug controller module and reconnect glow plugs.

Step 7

Place the supplied CARB E.O. Label on a clean, visible location under the hood.

Installation complete.
