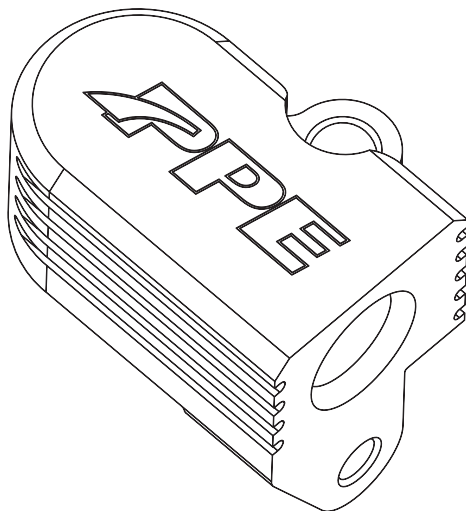
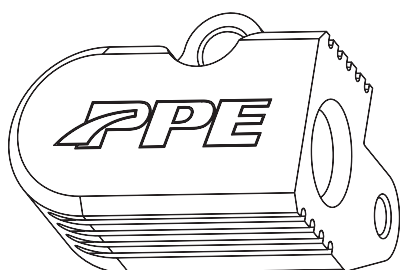




## **Upper MAP Sensor Relocation Block**

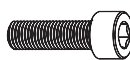

## INSTALLATION

1. Disconnect the negative battery terminal from both batteries and allow at least 15 minutes for the ECM to discharge.
2. Remove the 10mm bolt securing the MAP sensor to the intake manifold (2023+ model with separate IAT and MAP sensors shown). Remove the sensor, twisting while you pull to avoid damaging the O-ring. **(Fig. 1)**



3. Install the included Viton O-ring (B) into the PPE Spacer (A), applying a small amount of silicone grease or O-ring lubricant.
4. Install the PPE Spacer onto the intake manifold using the included Socket Head Cap Screw (C).
5. Install the MAP sensor into the PPE Spacer (A), twisting while inserting. Secure the sensor into the spacer using the factory 10mm bolt. **(Fig. 2)**



6. (Optional): If installing both sensor spacers on a 2023+ vehicle, repeat steps 2-5 for the other sensor.
7. Reconnect the negative terminal on both batteries.
