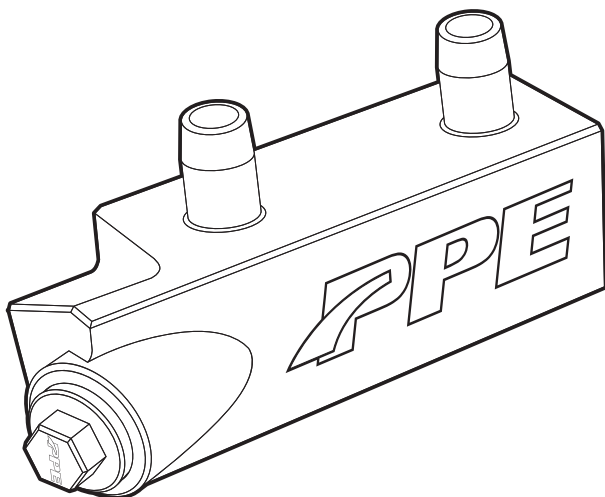

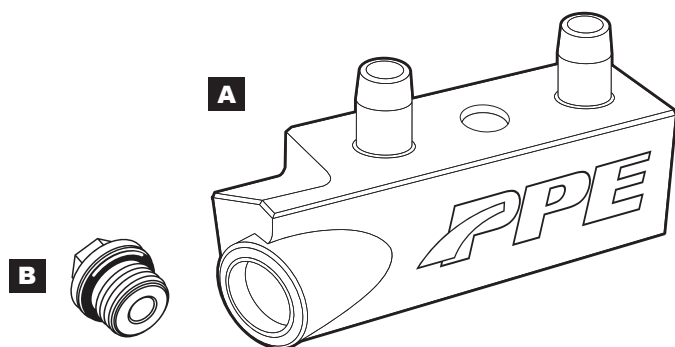

CONTENTS:

A (1) Transmission Fluid Thermal Bypass Valve - 6L80

B (1) Service plug with Neodymium magnet (installed)





INSTALLATION

1. Engine off and cool.
2. Unbolt factory bypass valve.
3. Unbolt factory hard line couplers. temporarily wrap factory lines to absorb fluid.
4. Remove factory bypass valve.
5. Install factory hard lines to the new PPE Trans Bypass Block. Reinstall mounting bracket and bolt. Tighten to secure assembly.
6. Install PPE Trans Bypass Block. Reinstall factory bolt to secure PPE Trans Bypass Block to trans. Tighten to secure.
7. Tighten Service Plug to 12-15 lb-ft
8. Top off fluid if needed.
9. Start engine. Check for leaks
