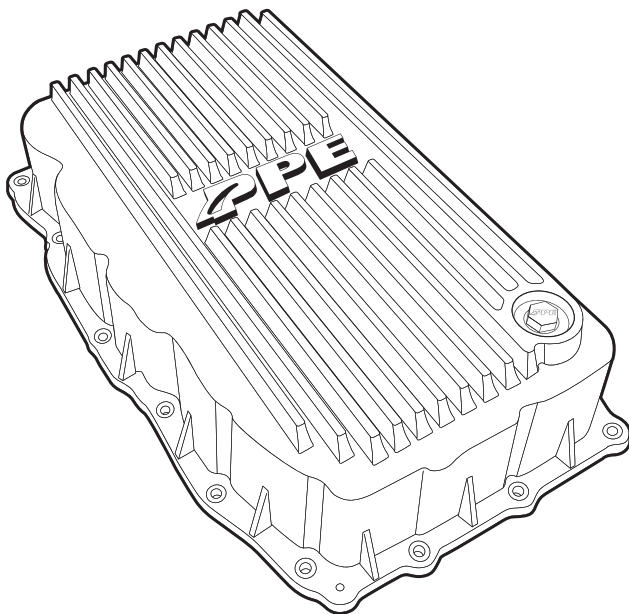
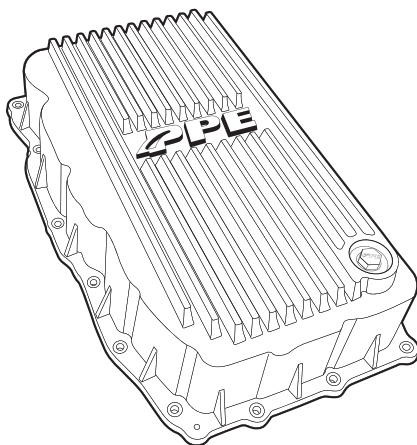




## **Heavy-Duty Cast Aluminum Deep Transmission Pan**

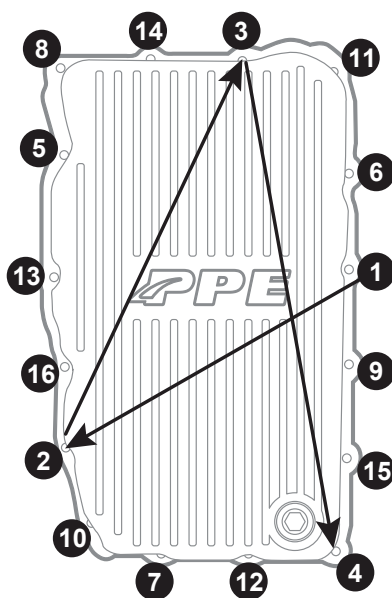
- A. Neodymium Drain plug (1) (installed)    D. M6 flat washers (16)
- B. PPE Deep Transmission Pan (10L80) (1)    E. 1/8" NPT plug (1) (installed)
- C. M6-1.0 x 30mm socket head cap bolt (16)

## **INSTALLATION:**

1. Vehicle off. Engine cool.
  2. Remove stock pan bolts. Carefully drain fluid.  
Save and clean reusable gasket.
  3. Fit reusable gasket on to new PPE Transmission Pan (B).
  4. Position Pan (B) in place. Check that gasket is aligned correctly. Don't forget to use the washers (D) when installing the bolts (C). Install two bolts (C) on either side of the Pan to hold pan in place. Finger tight for now.
  5. Install remaining bolts (C). Tighten in crossing pattern as depicted in Fig 1. Torque bolts (C) 80 lb-in.
  6. Tighten NPT snug (E). Tighten drain plug 18 lb-ft.  
(Be mindful not to crush the O-ring)
  7. Fill with manufacturer recommended transmission fluid.
- Check for leaks.

This completes the PPE Pan installation.

Refer to the manufacturer's recommendations for additional procedures relating to the transmission.
