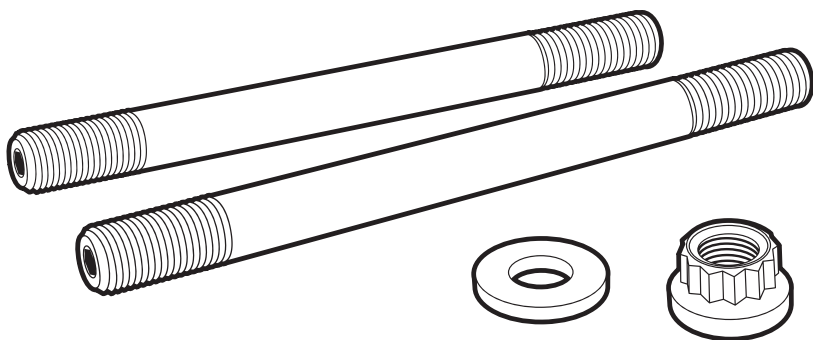




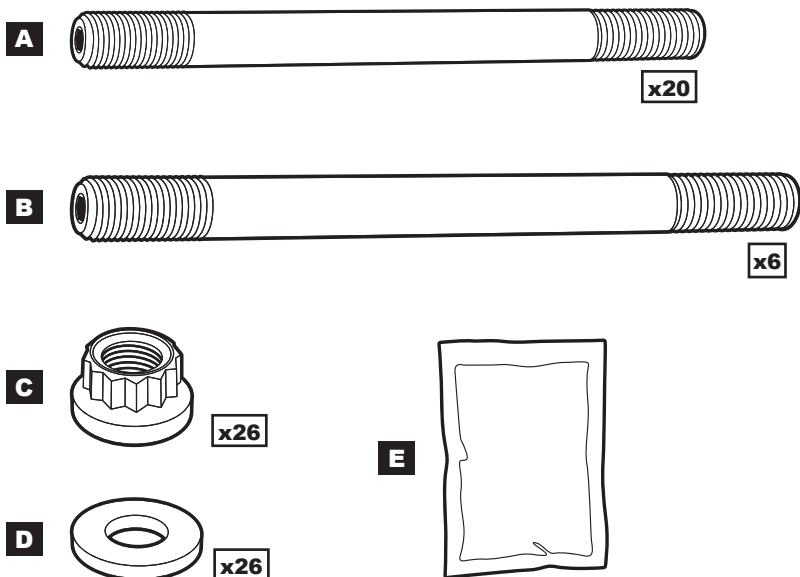

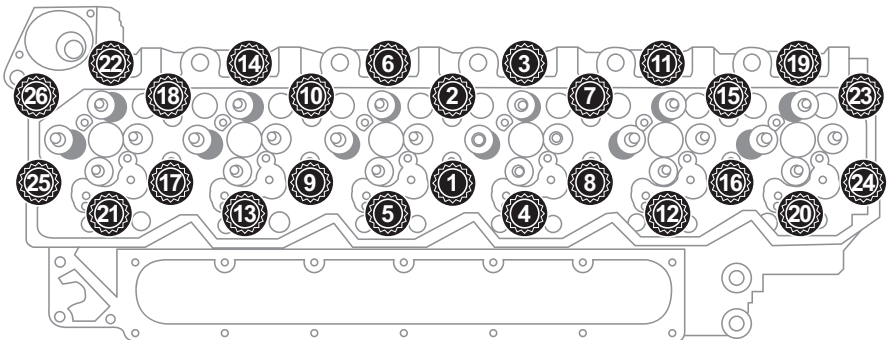
**PRODUCT
RESOURCES**

1. Inspect for damage or defects and clean all hardware prior to installation. Verify product part number matches your application.
2. Clean all threads in the engine block. Use a Bottoming Thread Chaser if necessary, to ensure thread engagement, and more accurate torque readings.
3. If the head studs protrude into a water jacket, use thread sealer to lubricate the block-end threads of the studs.
4. Install Studs (A) into the block. Hand-tighten without tools (equivalent of 20-30 in. lbs.). The 6.625" studs in this kit are installed along the exhaust manifold side of the cylinder heads in the number 22, 14, 6, 3, 11 and 19 positions of the torque sequence.
5. Verify consistant Stud (A, B) height using a straight-edge ruler.
6. Install cylinder head and check for proper alignment.
7. Lubricate Stud (A, B) threads, Flange Nuts (C) and Flat Washers (D) with the fastener assembly lubricant (E) provided. Install the Flat Washers (D) and Flange Nuts (C) on to the Studs (A, B).
8. Tighten nuts in three steps using the torque sequence illustrated below, to a final torque spec of 140 ft lbs.

Step 1 = 50 ft lbs

Step 2 = 95 ft lbs

Step 3 = 140 ft lbs
