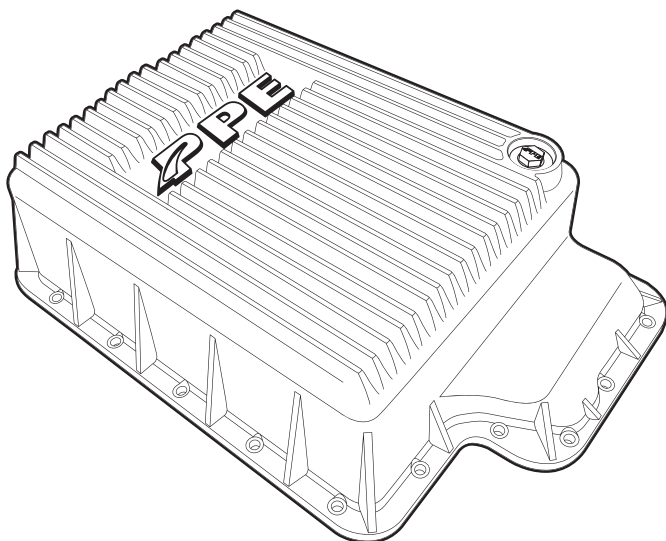


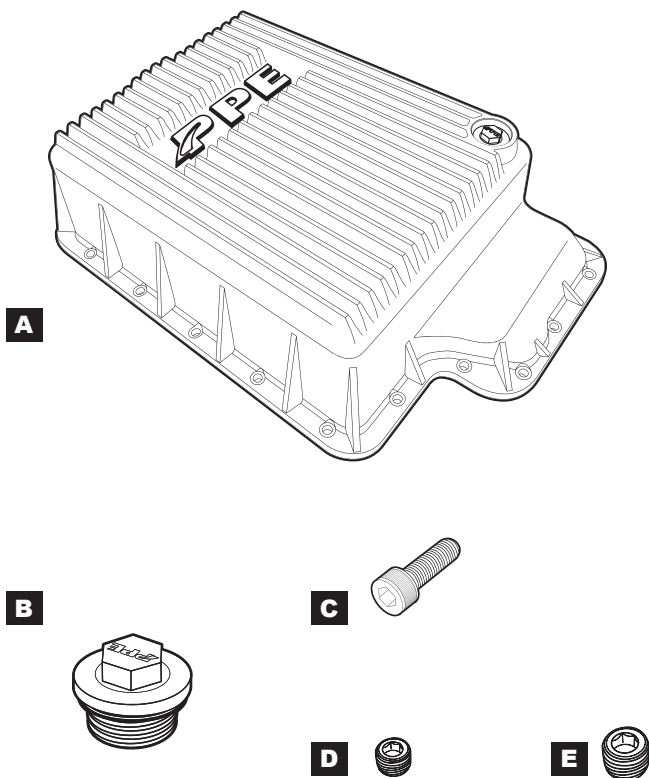


Heavy-Duty Cast Aluminum Deep Transmission Pan

Installation Guide



CONTENTS:

- A** (1) *PPE Deep Transmission Pan (5R110)*
- B** (1) *One-inch Neodymium Magnet equipped Drain Plug (installed)*
- C** (20) *M8-1.25 x 25mm socket head cap screws*
- D** (1) *1/8" NPT plug (installed)*
- E** (1) *1/4" NPT plug (installed)*

INSTALLATION:

Step 1. Vehicle off. Engine cool.

*Step 2. Remove stock pan bolts. Carefully drain fluid.
Save and clean reusable gasket.*

Step 3. Fit reusable gasket on to new PPE Transmission Pan.

Step 4. Install new transmission filter if necessary.

*Step 5. Position Pan in place. Check that gasket is aligned correctly.
Install two screws (C) on either side of the Pan to hold pan in place. Finger tight for now.*

*Step 6. Install remaining screws.
Tighten in crossing pattern as depicted in **Fig 1**.*

Torque screws to 8-10 ft. lbs.

*Step 7. Check and ensure both NPT
plugs (D, E) are tight.*

Tighten drain plug 18-22 ft lbs.

*Step 8. Fill with manufacturer
recommended transmission fluid.*

Step 9. Start engine. Check for leaks.

This completes the PPE Pan installation.

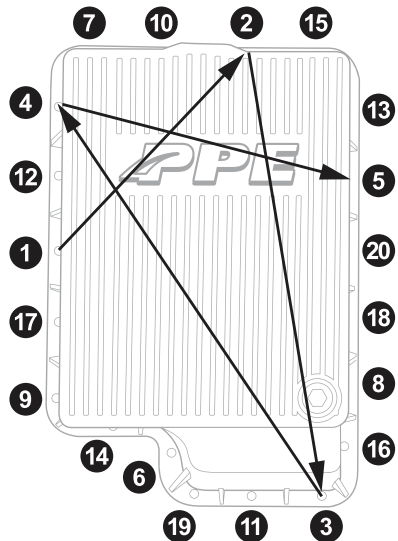

Performance products can increase horsepower above and beyond factory specifications. Additional horsepower creates more stress on the drive-train components, which could result in drive-train failure.

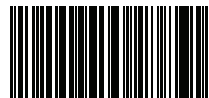
